The City of Centerton takes pride in the festival and would like to ensure that our customers receive the top quality of products offered from exhibitors. The City of Centerton asks that you help us make this a successful event with providing our customers a memorable time.

- Vendor Applications – All applications to be submitted no later than DECEMBER 1, 2017
- Applications - Will be subject to approval. A description of products to be sold or a brochure of products will need to be submitted with application.
- Inside booths are in Large Circus Tent and are approximately 10 X 10 spaces.
- All exhibitors are required to provide their own: tables, decorations, and any item used within their rented booths to maintain an attractive clean booth.
- Exhibitors must be setup prior to 10:00 a.m. and present during all hours open to the guest.
- Vendors are responsible of collecting all State, City and County Tax for their exhibit or food service.
- Booth assignments will be given to Exhibitors the day before the event.
- Cancellations - Cancellations need to be notified by December 8, 2017
- Electric Spaces – No electric will be available due to the Christmas Lighting in the Park.
- There will be a propane heater for the tent if weather permits.
