(1) Roll Call-

(2) Ordinance-

• Ordinance 2020-36- AN ORDINANCE ACCEPTING THE FINAL SUBDIVISION PLAT OF SOUTHWINDS SUBDIVISION PHASE 1, CREATING LOTS 1-113, LOTS A, B, C & TRACT "D", CITY OF CENTERTON, BENTON COUNTY, ARKANSAS.

Mayor Edwards addressed the Council, stating that this ordinance is to accept the Final Plat of the Southwinds Subdivision Phase 1, with 113 Single-Family Lots, at the northeast corner of Kimmel Road and Womack Road. He said it was approved by the Planning Commission on 7/07/20, with a \$25,000 Cash Performance Bond for 3 outstanding items. Edwards said the Bond has been received.
